PRINTING AND BINDING CONTRACT

BETWEEN

THE MINISTRY OF TRANSPORT REPRESENTED BY THE
HONORABLE MINISTER SAMUEL A. WLUE AND THE
MANAGEMENT OF YEASU PRINTING PRESS REPRESENTED
BY ITS GENERAL MANAGER, MR. ALBERT NUQUAY

THIS AGREEMENT made the 19 day of September
20 19 between **Ministry of Transport** of Liberia (hereinafter called
"the Purchaser") of the one part and **Y easu Printing Press** (hereinafter
called "the Supplier") of the other part:

WHEREAS the Purchaser invited Tenders for certain goods and
ancillary services, viz., **Printing and Binding Services** and has accepted
a Tender by the Supplier for the supply of those goods and services in
the sum of **Ten Thousand Two Hundred Fifty United States Dollars**
(USD 10,250.00) (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - (a) the Tender Form and the Price Schedule submitted by the Bidder;
 - (b) the Schedule of Requirements;
 - (c) the Technical Specifications;
 - (d) the General Conditions of Contract;
 - (e) the Special Conditions of Contract;
 - (f) the Purchaser's Notification of Award; and
 - (g) Contract Data Sheet (to be used only when there are corrections to the original price schedule submitted by the supplier).

3. In consideration of the payments to be made by the Purchaser to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Purchaser to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.

4. The Purchaser hereby covenants to pay the Supplier in consideration of the

provision of the goods and services and the remedying of defects therein, the

Contract Price or such other sum as may become payable under the provisions of the contract at the times and in the manner prescribed by the Contract.
