

Agreement

This agreement, made the _____ day of _____, 2022, between the **Ministry of Public Works** Represented by the Acting Minister, Hon. Ruth Coker Collins (hereinafter called the "Employer") and **ATLANTIC ENGINEERING CONSTRUCTION COMPANY LTD of the CITY OF PAYNESVILLE** represented by Mr. Wonkemie V. Zolia, General Manager (hereinafter called the "Contractor")


Whereas the employer desires that the Works known as Works Contract for the **Periodic Maintenance of Primary, Secondary & Feeder Roads, Graie to Behwalay (19km), Lot 3: IFB No. MPW/NRF/W/ICB/011/20/21** should be executed by the contractor, and has accepted the Bid by the Contractor for the execution and completion of these works and the remedying of any defects therein.

 - (e) The Specifications;
 - (f) The Drawings;
 - (g) The Priced Bill of Quantities; and
 - (h) Other documents, as listed in the Appendix to Bid
3. In consideration of the payments to be made by the Employer to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Employer to execute and complete the Works and remedy any defects therein in conformity in all respects with the provisions of the Contract.
4. The Employer hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein the Contract Price of **US\$202,706.80 (Two Hundred Two Thousand Seven Hundred Six United States Dollars Eighty Cents)** or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.




