TO AWARD CONTRACT FOR THE CONSTRUCTION OF REINFORCED
CONCRETE BRIDGE & DOUBLE CELL BOX CULVERT) IN VAHUN, LOFA
COUNTY - FY 2022.

We present our compliments and wish to acknowledge receipt of your letter and accompanying documents, which sought the approval for the Ministry of Public Works to award contract to Afro Construction Company for the construction of Reinforced Concrete Bridge and Double Cell Culvert in Vahun, Lofa County, in the amount of US\$710,756.48 (seven hundred ten thousand seven hundred fifty-six United States dollars and forty-eight cents).

The Commission upon review of the submission observes the following:

- That the Ministry of Public Works submitted the Invitation to bid/advertisement, bidding documents, Contractor's submission, letter constituting an Ad-hoc BEP, Bid Evaluation Report, PC meeting minutes endorsing the BEP's Report, Draft Contract, bid opening minutes and attendance.
- That Afro Construction Company was the lone bidder and as per MPW's BEP's report was deemed responsive to stipulated requirements;

The Commission, upon overall review of MPW's <u>submissions</u>, <u>clarifications and subsequent</u> <u>accompanying documents</u>, states below:

- 1. That "No Objection" is rendered to Ministry of Public Works to award contract to Afro Construction Company for the Construction of reinforced Concrete Bridge and Double Cell Box Culvert in Vahun, Lofa County, in the amount of US\$599,117.39 (five hundred ninety-nine thousand one hundred seventeen and thirty-nine cents);
- 2. That these costs: Contingency costs (US\$13,282.35), Project vehicle (US\$65,000.00) and Supervision Logistics (US\$33,205.87) are extracted from the overall costs, given the already quoted costs by the sole bidder;
- 3. MPW is to ensure quality conformance given the nature of works.

Please note that all contracts which cumulative annual value above the threshold of US\$250,000.00 must be attested by the Minister of Justice and signed by the Minister of Finance, and also go through all subsequent requisite approval procedures where applicable. The Commission requires that you kindly forward copies of all approved stipulated contracts upon signing, as required under governing procurement rules.

The Public Procurement and Concessions Commission admonishes and it a priority that you remain primarily in compliance with the PPCA, 2010, as we jointly aspire to achieve transparency, accountability, fairness, equality and ultimate public confidence in our procurement and concession
