SUBJECT: MPW's SPECIAL PROJECT WORKS PROCUREMENT PLAN FOR THE PAVEMENT OF THE OMEGA MARKET CORRIDORS

We present our compliments and wish to notify you that the Public Procurement and Concessions Commission has received and approved the Ministry of Public Works Special Project Works Procurement Plan for Pavement of the Omega Market Corridors. The Commission conveys to the MPW, that the Procurement Plan will be duly forwarded to the Ministry of Finance and Development Planning (MFDP), and MFDP should process allotments upon conclusion of stipulated processes outlaid in the Procurement Plan.

The Commission counsels that you observe **Section 40(5)** of the PPCA, 2010 which states "each Procuring Entity, shall, on a quarterly basis and whenever it becomes necessary, review and update its procurement plans and notify the Commission in writing and the Minister of Finance of any material changes in its plan. An updated procurement plan shall accompany said notice to the Commission.

Please note that an approval of a method on the procurement plan is deemed as the Commission's full approval and as such a Procuring Entity will not be required to again request the use of said approved method. The Commission lauds the MPW for a move to competitive process for this contract package and advices adherence to required lead time for stipulated procurement methods.

The Public Procurement and Concessions Commission admonishes and deems it a priority that you remain primarily in compliance with the PPCA 2010 as we jointly aspire to ensure the National interest is assured and ultimately public confidence is maintained in all Public Procurement and Concession processes.

Request for "No Objection" for MPW Special Project Procurement Plan

I write in compliance with section 40 count (2) of the Public Procurement and Concessions Act (PPCA) of 2010, to submit the Ministry of Public Works special project procurement plan for the pavement of the Omega Market Corridors for approval.

In view of the aforementioned, the Ministry seeks to request for "No Objection" for the use of Restricted Bidding Method of the PPCA with reduction in lead time due to the followings:

- 1. The nature and complexity of works to be done
- 2. The urgent need to decongest the redlight traffic/corridor for the onging road contruction from ELWA Junction to Parker Paint
- 3. The need to relocate the Redlight Market to the Omega Market.

The Procurement committee also considered the use of the Restricted Bidding Method inorder to:

- 4. Minimize the cost associated with advertisment of the bidding process
- 5. Honor this Special Presidential project that seeks to redue the constraints (Flood & transporatation of goods) face by our market women during the rainy season.
