

Agreement

This agreement is made and entered into this _____ day of February, 2022, between the Ministry of Public Works Represented by the Acting Minister, Hon. Ruth Coker Collins (hereinafter called the "Employer") and INMACO TRADING of Congo Town, Monrovia, represented by Mr. Imad Nassar Chief Executive Officer (hereinafter called the "Contractor")

Whereas the employer desires that the Works known as Works Contract for the Periodic Maintenance of Primary, Secondary & Feeder Roads, Doe Estate to Graceland (6.5km), Lot 1: IFB No. MPW/NRF/W/ICB/011/20/21 should be executed by the contractor, and has accepted the Bid by the Contractor for the execution and completion of these works and the remedying of any defects therein.

- In consideration of the payments to be made by the Employer to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Employer to execute and complete the Works and remedy any defects therein in conformity in all respects with the provisions of the Contract.
- 4. The Employer hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein the Contract Price of \$418,426.07 (Four Hundred Eighteen Thousand Four Hundred Twenty-Six United States Dollars Seven Cents) or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.




