Subject: RECEIPT AND APPROVAL OF MINISTRY OF YOUTH AND SPORTS UPDATED NON-SBA PROCUREMENT PLAN FOR FISCAL YEAR 2021

We present our compliments and wish to notify you that the Public Procurement and Concessions Commission has received and approved the Ministry of Youth and Sports (MYS) Updated Procurement Plan (Non-SBA) with a two-week reduction in lead time, for Fiscal Year 2022 in accordance with **Section 40** (3) of the PPCA, 2010. The Commission informs the MYS that its Updated Project Procurement Plan will be duly forwarded to the Ministry of Finance and Development Planning (MFDP), and that the MFDP will process allotments in keeping with the approved Procurement Plans.

The Commission counsels that you observe Section 40(5) of the PPCA, 2010 which states "each Procuring Entity, shall, on a quarterly basis and whenever it becomes necessary, review and update its procurement plans and notify the Commission in writing and the Minister of Finance of any material changes in its plan. An updated procurement plan shall accompany said notice to the Commission."

Please note that an approval of a method on the procurement plan is deemed as the Commission's full approval and as such a Procuring Entity will not be required to again request the use of said approved method.

Please note that all contracts which cumulative annual value above the threshold of **US\$250,000.00** must be signed by the Minister responsible for Finance and attested by the Minister responsible for Justice. **The Commission requires that you kindly forward copies of all stipulated contracts upon signing, so as to update our records**.

The Public Procurement and Concessions Commission admonishes and deems it a priority that you remain **primarily** in compliance with the PPCA, 2010, as we jointly aspire to achieve transparency, accountability, fairness, equality and ultimately public confidence in our procurement and concessions processes.

SUBJECT: REQUEST FOR ''NO OBJECTION'' TO USE RESTRICTED BIDDING TO CONTRACT A FUMIGATION COMPANY FOR CLEANING & REMARKING OF THE TRACK AROUND THE SKD SPORTS PITCH.

The Ministry of Youth and Sports extends her compliments and hereby request the Commission's approval to grant "NO OBJECTION" to use **Restricted Bidding** for the purpose of contracting a **Fumigation Company** for cleaning and re-marking the track around the SKD Sports Pitch.

The cost of the cleaning is in the sum of US\$ 40, 000.00 (Forty Thousand United States Dollars); and it is intended to give the field a complete face lift after the laying of the artificial turf. The amount for the cleaning was previously approved by the Commission in our 2022 procurement plan under the contract package "Furniture & Fixture" drawn from the budget line Transfer to SKD. The Ministry intends to no longer procure furniture & fixture but use portion of such amount towards the cleaning and re-marking of the track.

In furtherance, we kindly request that the Commission permit us to use two weeks lead time for the conduct of the process as opposed to the normal four weeks stipulated by law.

The Ministry looks forward to your timely response and appreciates the Commission's continual efforts to Youth and Sports Development initiatives.
