FLOODLIGHTS - FISCAL YEAR 2023

We present our compliments and wish to acknowledge receipt of your letter which sought the approval of the Commission for Ministry of Youth and sports (MYS) to award contract to Greenfield A Tencate Company for the installation of Floodlights and in the amount of five hundred thousand United States Dollars <u>US\$500,000.00</u>.

The Commission, upon review of your submissions, highlights the following:

- That the MYS submitted (Hard copies) including: <u>bid documents</u>, <u>bid evaluation report</u>, <u>bid invitation</u>, <u>FIFA approved list of suppliers</u>, <u>draft contract</u>, <u>etc.</u>;
- That the MYS BEP's Report indicates that invitation was sent to six (6) approved suppliers and only one (1) bidder submitted: (Greenfield A Tencate Company);
- That MYS has an approved procurement plan in the amount of <u>US\$500,000.00</u> for this contract package;
- That the MYS recommended most responsive bidder (Greenfield A Tencate Company)
 proposed contract amount is <u>US\$597,000.00</u>, contrary to its approved amount for the
 stipulated contract package.

The Commission, upon overall review of your submission renders "No Objection" for the Ministry of Youth and Sports (MYS) to award a contract to Greenfield A Tencate Company for the installation of Floodlights and in the approved amount of five hundred thousand United States Dollars U\$\$500,000.00.

Kindly be reminded that all contracts which cumulative annual value exceeds the threshold of **US\$250,000.00** must be signed by the Minister responsible for Finance and attested to by the Minister responsible for Justice.

The Public Procurement and Concessions Commission admonishes and deems it a priority that you remain, **primarily**, in compliance with the PPCA, 2010, as we jointly aspire to achieve Transparency, Accountability, Fairness, Equality and Ultimately public confidence in our procurement and concessions processes.
