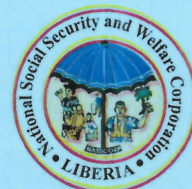

Subject: **"NO OBJECTION TO AWARD CONTRACT TO AMINATA AND SONS FOR THE SUPPLY AND DELIVERY OF PETROLEUM PRODUCTS AND CONEX ENERGY FOR GASOLINE AND DIESEL IN COUPONS FOR FISCAL YEAR 2023."**

We present our compliments and wish to acknowledge receipt of your letter which sought the approval of the Commission for the National Social Security & Welfare Corporation to award Petroleum Contract to Aminata and Sons (Lot#1) for the supply of Gasoline and Diesel coupon in the amount of **US\$1,033.016 (one million thirty-three thousand United States dollars and sixteen cents)** and Conex Energy (Lot#2) for the supply of Diesel bulk in the amount of **US\$40,000.00 (forty thousand united states for Fiscal Year 2023 in accordance with Section 40 (3) of the PPCA, 2010 and Section 55(d).**

The Commission, upon review of your submissions, highlights the following:

- That the NASSCORP submitted (Hard copies) including: bid opening reports, details of minutes and attendance, bid evaluation report for contract award, draft framework contract, bid evaluation report, bidders submission, minutes of procurement committee, bid attendance log and signing sheets;
- That the NASSCORP submitted the Standard bidding document for the supply of petroleum products, invitation for bid letters issued to Petro Trade, Aminata and Sons, LIB Afric and Associates, Nexium Petroleum and Conex Energy. These were the 5 companies invited to participate in bidding process; and Aminata and Sons and Conex emerged as the most responsive bidders for the supply of Petroleum products.

The Commission, upon overall review of the NASSCORP's request and justification states below:

That "No Objection" is rendered for the National Social Security and Welfare Corporation to award Petroleum Contract to Aminata and Sons (Lot#1) for the supply of Gasoline and Diesel Coupon in the amount of **US\$1,033.016.00 and Conex Energy (Lot#2) for the supply of Diesel bulk in the amount of US\$40,000.00 United States dollars respectful.**

Please note that all contracts which cumulative annual value above the threshold of **US\$250,000.00** must be signed by the Minister responsible for Finance and attested by the Minister responsible for Justice.

The Public Procurement and Concessions Commission admonishes and deems it a priority that you remain **primarily** in compliance with the PPCA, 2010, as we jointly aspire to achieve transparency, accountability, fairness, equality and ultimately public confidence in our procurement and concessions processes.
