As per the execution of the project activities, the workshop will be held in each of those five (5) counties mentioned herein for three (days) each. As for the Procurement Method, the Procurement Unit decided to use the RFQ due to the various venues of the workshop and activities, insufficient funds to underwrite other cost, such as hiring Caterer from Montserrado to the other counties; and also, the impossibility for vendors in the other Counties to participate in the procurement vetting processes are some of the reasons we thought of not using NCB or RB method. By using this RFQ Procurement Method, other vendors in those counties that will be selected for the workshop will be given the opportunity to participate in the process as well.
