SECURITY SERVICE CONTRACT

This **SECURITY CONTRACT**, made and entered into this 2nd day of July A. D 2019.

BY AND BETWEEN

Professional Protective Services Incorporated as the Agent and is hereby referred to as PPSI

AND

The National Commission on Disabilities of the Republic of Liberia, as the Principal, and is hereby referred to as the NCD.

The total value of the contract is **US\$7,620.00 (Seven Thousand Six Hundred Twenty United States Dollar)** for the provision of Security Guards for the Fiscal Year 2019/2020; Monthly **US\$635.00. (Six Hundred Thirty Five United States Dollars).** Payment can be made either on a **Monthly or Quarterly** basis.

This contract is subject to revision at any point in time when the need arises.


WITNESSETH


1. It has been mutually agreed and understood by and between the Agent and the principal that the Agent shall undertake the protection of the Principal's premises for an initial period of Twelve (12) months, commencing from the 2nd day of July A.D 2019 to the 30th day of June A.D 2020.
2. That the Agent is hereby authorized to assign One(1) officer(s) on the 1st shift: (7:00 AM-3:00PM.), TWO(2) officer (s) on the second shift: 3:00PM-11:00PM), and Two(2) officer(s) on the third shift(11:00PM-7:00AM) for the purpose of protecting said premises, totaling Five (5) guards @ US\$127.00(One Hundred Thirty Six United States Dollars Seven cents per Guard; total to pay monthly **US\$635.00. (Six Hundred Thirty Five United States Dollars).**
3. That both parties shall conduct a crime prevention survey, and also take inventory of the premises jointly, which shall be on the basis of verification by each shift and may be amended from time to time as may be necessary by both parties.
4. That, in an event of a burglary or theft while PPSI, INC. officer(s) is/are on duty, a full scale investigation surrounding any incident shall be conducted and PPSI, INC. shall be held liable if the crime committed was due to the negligence of the officer (s), the value of the stolen item(s) shall be appraised and paid for by the Agent.
5. That, in an event of burglary /theft, the crime scene should be preserved, (not tampered with), pending the arrival of this Agent or his representative(s).


6. That, the Agent will not be held liable in the event of acts such as civil uprising, invasion, war, and arson or strike actions.
7. That, the Principal/Representative shall inform the Agent of the rules and regulations of the premises to be enforced by the Security officer (s), on duty.
8. That, all entrances/exits (gates) to the premises of the Principal be locked and keys kept by the Agent to ensure guarantee.
9. That, before the signing of this contract, GSS, INC. will conduct a security survey of the installation and forward recommendations for implementation. Should the Principal fail to follow the recommendations for possible implementation and crime prevention, crime resulting to burglary/theft due to said failure, GSS, INC. will not be held liable.
10. That, a written notice of termination of service shall be forwarded within thirty-one (31) working days, should any of the parties deem it necessary.
11. That should the Principal fail to make payment to the Agent after fifteen (15) days of the preceding month for security services rendered; Management deserves the right to terminate the contract without further notice.
12. That, should the Principal terminate the contract for inefficiency of Agent, poor performance of guard(s), or other reason (s), and employ the same guard (s) who serve during the tenure of the contract, the Principal shall be held liable for damages, and the appropriate legal action(s) will be instituted by the Agent against the Principal.
13. This Agreement shall bind the parties hereto, and their successors in business/office as though they were specifically name herein.
