RECEIPT AND APPROVAL OF NHA'S SOLE SOURCE CONCESSION PROCUREMENT PLAN BASED ON A CABINET RESOLUTION FOR THE GRANTING OF LAND TO BUILD 2000 HOUSING UNITS

We present our compliments and acknowledge receipt of your letter submitting documentation seeking the Commission's approval of the National Housing Authority Sole Source Concessions Procurement Plan request for the granting of land to build 2000 housing units in Grand Bassa, Bong, Montserrado, Margibi, Grand Cape Mount and Nimba Counties, in accordance with PPCA 101 (2)(b) and Section 79 (2).

The Commission upon review of submitted documents notes the following:

- ✓ That this Sole Source Concession was determined by the Cabinet based on PPCA Section 101(1)(d), citing strategic national interest;
- That an official communication from the Director General of the Cabinet transmitting this Cabinet Resolution was sent to the Commission;
- ✓ That the NHA submitted a Concession Procurement Plan in consonance with PPCA Section 101 2(b) and
- ✓ That clarifications and justifications were made by the <u>Ministry of Justice</u> and the <u>NHA</u> regarding the Sole Bidder's legitimacy, financial capacity and experience.

The Commission upon review of the above, approves the NHA Concession Procurement Plan and states the following:

- That the NHA abide by all procedures relating to PPCA 101 (2);
- That the Commission will publish the determination by the cabinet for at-least two weeks in consonance with PPCC 101(2)(a);
- That Negotiations on this Sole Source Concession shall not occur until the Cabinet Determination is published for at least two weeks;
- That thorough due diligence must be made on the concessionaire's Technical and Financial capacities;
- That Negotiation should take into consideration PPCA Section 119;
- That the Draft Contract should be sent to the Commission for review and advisory, and
- That the Legislature should review and rectify where applicable.

The Commission states that the concession must meet objectives as enshrined in PPCA Section 74, not excluding the acceleration of development of infrastructure, human capacity and provision of services, Development of renewable resources of Liberia consistent with other national goals and job creation that will consequently assist Liberia's national development.

Therefore, the Commission advises that the NHA implements the aforementioned concession process in keeping with the timeline and processing steps captured in the plan submitted to the Commission and is require to seek guidance from the Commission during the implementation of the process leading to the award of proposed concession. Additionally, NHA, shall on a quarterly basis and whenever it becomes necessary, review and update its concessions plan.

The Public Procurement and Concessions Commission admonishes and deems it a priority that you remain primarily in compliance with the PPCA, 2010, as we jointly aspire to achieve transparency, accountability, fairness, equality and ultimately public confidence in our procurement and concessions processes.
