Subject: NHA'S REQUEST FOR SOLE SOURCE APPROVAL TO LAMCO -CONCESSION OF 985 ACRES OF LAND TO CONSTRUCT 2000 HOUSING UNITS IN LOWER MARGIBI COUNTY.

We present our compliments and acknowledge receipt of your letter submitting documentation seeking the Commission's approval of the National Housing Authority to Sole Source Liberia Asset Management Company (LAMCO), based on an unsolicited proposal, for the concession of 985 acres of Land in Lower Margibi County to construct 2,000 Housing Units, in Lower Margibi County.

The Commission upon review of submitted documents states the following:

- 1. That in consonance with the provisions of the PPCA 2010, Public Private Partnership/Concession can be done through a Solicited approach (Section 95) and or Unsolicited approach (Section 101) (3); The NHA should note that an unsolicited proposal may still be subjected to competition, in consonance with PPCA Section 101(d).
- 2. That the utilization of the Solicited approach fosters competition, transparency, fairness etc. Furthermore, <u>not executing a competitive PPP/Concession process</u> prevents an effective competition, value for money and options of comparative offers.
- 3. Thus, the Commission advises the NHA to institute a competitive process to attain suitable bidders that will consequently yield competition, generation of best and comparative technical and financial offers, and value for money, for such a significant developmental project for Liberia.
- 4. The NHA should follow requisite procedures in line PPCA, to commence an appropriate process and also craft the applicable Procurement Plan for subsequent review by the Commission, upon conclusion of stipulated preliminary procedures.

The Public Procurement and Concessions Commission admonishes and deems it a priority that you remain primarily in compliance with the PPCA 2010 as we jointly aspire to ensure the National Interest is assured and ultimately public confidence is maintained in all Public Procurement and Concession processes.
