FRAMEWORK AGREEMENT FOR THE SUPPLY OF STATIONERY ITEMS & INK &CARTRIDGES

THIS FRAMEWORK AGREEMENT (the "AGREEMENT") is made and entered into this $\frac{f^{\delta i}}{day}$ of JUNE-----. 2022, by and between

THE NATIONAL INVESTMENT COMMISSION, an Agency of the Government of Liberia (hereinafter referred to as the "PURCHASER"), located on United Nations Drive, Monrovia, Liberia and represented by its Chairman, Hon. Molewuleh B. Gray and,

UNITED OFFICE SUPPLIES & EQUIPMENTS (herein referred to as the "SUPPLIER"), an entity incorporated under the laws of the Republic of Liberia with principal place of business on Benson & Mechlin Streets, Monrovia, Liberia and represented by its General Alanager, Mr. Hitesh M. Thakur (hereinafter called the "SUPPLIER").

The PURCHASER and SUPPLIER are hereinafter collectively referred to as the "PARTIES".

WITNESSETH

WHEREAS the SUPPLIER is an entity registered under the laws of the Republic of Liberia, whose principle business is the supply and sales of books, newspapers and Stationery in specialized stores and other related products.

WHEREAS, the PURCHASER desirous of fulfilling its consumable needs, utilized section 53 of the Public Procurement and Concession Laws of Liberia 2010, Request for Quotation, received submissions, evaluated same pursuant to section 54 of the said Act, and wishes to award the SUPPLIER a contract for the supply of Stationeries & Ink;

WHEREAS, the Purchaser intends to apply a portion of its budgetary appropriation to the procurement of Stationery & Ink supplies for the period of JUNE 1, 2022 to December 31, 2022; and

WHEREAS, the SUPPLIER has accepted the engagement and warrants that it has the wherewithal to supply stationery & Ink items to the PURCHASER during the period mentioned supra;

NOW THEREFORE, for and in consideration of the mutual promises and agreements herein contained, the PARTIES hereto agree:

ARTICLE 1 SUPPLY OF GOODS

The PARTIES have agreed that the SUPPLIER shall supply and deliver to the PURCHASER the quantity of Stationery Materials and ink Cartridges requested based upon the pre-agreed unit prices quoted below by the SUPPLIER:

ARTICLE II DURATION

The duration of this agreement is for the period of Seven (?) Months commencing, June 1, 2022 to December 31, 2022 \bigcirc

ARTICLE III PAYMENT

For cash transactions, payments shall be made by checks drawn in favor of the SUPPLIER and paid to its head office before delivery of the supplies.

In the event a credit account has been established and agreed between the PARTIES, delivery of supplies will be made against a purchase order and payment made by checks drawn in favor of the SUPPLIER within a month from the date of delivery.

ARTICLE IV SERVICE AND SUPPLIES

The SUPPLIER agrees and stipulates that in the event the PURCHASER reports a problem or defect with the stationery items & Ink Cartridges or related materials, the SUPPLIER shall make a reasonable effort to rectify said defect in three (3) working days.

ARTICLE V FORCE MAJEURE

In the event of force majeure or other supervening events which could render this agreement inoperable, the terms and conditions of this agreement shall be automatically suspended and shall remain suspended until such time when the force majeure no longer exists. Force Majeure as used herein is defined as any event beyond the reasonable control of the PARTIES, including Acts of God, war, civil commotion, armed incursion, armed insurrection, storm, floods, epidemic, fire, lightening or conditions that could not have been expected, prevented or controlled, and not attributable to the fault or neglect of the PARTIES.

ARTICLE VI PRIVITY

The benefits and obligations of this Framework Agreement shall respectively mure to, and be binding upon the PARTIES hereto, their legal representative and/or successors-in-interest as if they were specifically mentioned herein by name.

ARTICLE VII MODIFICATION

This Contract constitutes the entire agreement between the Parties and supersedes any and all oral and/or written statements, discussions and agreements made by either Party to the other. No modification of this Contract shall be binding on either Party unless it is in writing and signed by both Parties.

ARTICLE VIII GOVERNING LAW

This agreement shall be governed by the laws of the Republic of Liberia.
