Subject: PPCC RESPONSE: "NO OBJECTION" TO AWARD CONTRACT TO BMC GROUP INCORPORATED FOR THE BUILDING OF A FIVE (5) STORY BUILDING FOR FISCAL YEAR 2023.

We present our compliments and wish to acknowledge receipt of your letter which sought the approval of the Commission for the National Oil Company of Liberia to award Contract to BMC Group Incorporated for the building of a 5 (five) story building in the amount of US\$2,913,857.67 (two million nine hundred thirteen eight hundred fifty-seven and sixty-seven cents United States dollars.

The Commission, upon review of your submissions, highlights the following:
