## 1.0 Introduction and Summary

In keeping with Sections 27(g) and 43(9), of the Amended and Restated Public Procurement and Concession Act which requires each Procuring Entity to submit quarterly report to the Commission, I am pleased to submit the Procurement Report for 2<sup>nd</sup> Quarter, Fiscal Year 2022 for your review and consideration.

During the period under review, *National Transit Authority* has completed the implementation of *two (2) special project procurement packages* as approved by the PPCC for the period under review.

Thus far, a total of two contract packages was implemented through one (1) procurement method as follow: SBA-Procurement, Sole Source method (2).

## 2.0 Challenges

Some challenges and constraints encountered during the course of the quarter while implementing planned procurement activities were undue influences from the Senior Management team. Additionally, Other Includes:

- 1.Immobility to adequately execute planned procurement activities, which most of the time pose an impediment to the timely completion of assigned tasks;
- 2.Incomplete/limited specifications from End-User departments; and
- 3. Delay in getting allotments from the Ministry of Finance and Development Planning (MFDP) to implement timely planned Procurement activities.

## 3.0 Recommendations

It is hope that the SeniorManament Team will provide a **utility vehicle** to the Procurement Unit to promptly execute timely completion of planned procurement tasks.
