However, an updated procurement plan shall accompany said notice to the Commission."

Please note that an approval of a method on the procurement plan is deemed as the Commission's full approval and as such, a Procuring Entity will not be required to again request the use of said approved method.

The Public Procurement and Concessions Commission admonishes and deems it a priority that you remain primarily in compliance with the PPCA, 2010, as we jointly aspire to achieve transparency, accountability, fairness, equality and ultimately public confidence in our procurement and concessions processes.

- 2. Upgrade of the solar panel system installed by Easy Solar Liberia, which serves as a backup power source in the absence of LEC.

We kindly request the PPCC's review and subsequent approval of our Annual Procurement Plan, along with consideration for our No Objection request above.

We remain committed to upholding transparency, accountability, and public trust in all procurement processes and appreciate your continued cooperation in this regard.
