

The Public Procurement and Concessions Commission admonishes and deems it a priority that you remain primarily compliant with the PPCA, 2010, as we jointly aspire to achieve transparency, accountability, fairness, equality, and ultimately public confidence in our procurement and concessions processes.

Kindly accept sentiments of highest esteem and sincere best wishes for your administration of the PPCC; please also be assured of our cooperation with your office in ensuring effective performance of the services for which our two institutions are established.

Consistent with Section 40(2) of th4e Amended and Restated PPCC Act of 2010, the Office for the Establishment of War and Economic Crimes Court for Liberia (OWECCL) hereby submits its Procurement Plan in this Fiscal Year 2025, for grant fund received from the Government of Liberia for Fiscal Year 2024, for your kind approval. Accompanying this plan are the requisite documents supporting this submission.

This 2024 procurement process is predicated on the fact that (1) the OWECC-L became operational on November 1, when the President, His Excellency Joseph Nyuma Boakai, Sr. appointed the undersigned Executive Director; and (2) funding to the OWECC-L was available to it by the Government this month, after a period of uncertainty as to the amount the Office would be funded with.

While we assure of our resolve to function within the pale of the law, we are also under pressure to request your first, your approval of this Plan and second, to grant us a waiver of the regular process because of the urgency to meet dire implementation demands of the many activities already overdue. Additionally, Honorable Director, we expect a high power expert delegation to Liberia to work with us in regard of our mandate and would be in an extremely difficult situation if this Plan is not approved and put into motion speedily.


