We present our compliments and wish to notify you that the Public Procurement and Concessions Commission request to use the Restricted Bidding Method with a reduction in lead from four weeks to two weeks for the purchase of a 32-seater bus for employees of the Commission is hereby granted in accordance with Section 40 (3) of the PPCA, 2010.

The Commission and the Ministry responsible for Finance should be notified in writing of any material changes in the procurement plan and be provided with a copy of the updated procurement plan. Please note that an approval of a method on the procurement plan is deemed as the Commission's full approval and as such a Procuring Entity will not be required to again request the use of said approved method.

The Public Procurement and Concessions Commission deems it a priority that you remain primarily in compliance with the PPCA, 2010, as we jointly aspire to achieve transparency, accountability, fairness, equality and ultimately public confidence in our procurement and concessions processes.
