We present our compliments and wish to acknowledge receipt of your letter responding to the Commission queries on the Booker Washington Institute decision to award contract to Jungle Water Group of Investment for the supply of assorted non-frozen food for 2020/2021.

The Commission upon review of your request and accompanying documents, observed the following:

- o That the BWI provided no evidence on its assertion that Harbel Supermarket price offers are "deceptive".
- o That both Jungle Water and Harbel Supermarket are recorded to have passed all the preliminary and qualification requirements, thus both should be processed for the financial evaluation stage as per procedures.
- o That the Commission, in reference to the above inconsistencies, states that the resubmitted Evaluation Report **does not reflect** an outcome in line with BWI's own predetermined criteria, and thus **is not approved**.

The Public Procurement and Concessions Commission admonishes and deems it a priority that you remain primarily in compliance with the PPCA, 2010, as we jointly aspire to achieve transparency, accountability, fairness, equality and ultimate public confidence in our procurement and concession processes.
