

Subj: <u>APPROVAL OF RIVER GEE COUNTY SERVICE CENTER PROCUREMENT PLAN</u> FOR FISCAL YEAR 2025

We present our compliments and wish to acknowledge receipt of your communication dated April 21, 2025, which sought the approval of the Commission for River Gee County Service Center Procurement Plan for Fiscal Year 2025.

Following thorough review, the Commission hereby approves the River Gee County Service Center Procurement Plan for Fiscal Year 2025 in accordance with Section 40 (3) of the PPCA, 2010, and informs River Gee County Administration that its County Service Center procurement plan for 2025 will be duly forwarded to the Ministry of Finance and Development Planning (MFDP), and that the MFDP will process allotments in keeping with the approved procurement plan.

The Commission counsels that you observe Section 40 (5) of the PPCA, 2010, which states "each Procuring Entity, shall, on a quarterly basis and whenever it becomes necessary, review and update its procurement plans and notify the Commission in writing and the Minister of Finance of any material changes in its plan. However, an updated procurement plan shall accompany said notice to the Commission." Please note that an approval of a method on the procurement plan is deemed as the Commission's full approval and as such, a Procuring Entity will not be required to again request the use of said approved method.

The Public Procurement and Concessions Commission admonishes and deems it a priority that you remain primarily in compliance with the PPCA, 2010, as we jointly aspire to achieve transparency, accountability, fairness, equality and ultimately public confidence in our procurement and concessions processes.

I am pleased to present compliments and to inform you that River Gee County Administration is about to conduct a procurement process in favor of the County Service Center as per the attached Procurement Plan and Cash Plan from its FY2024 Budget.

In view of the above, the River Gee County Administration requests "No Objection" to use the Request for Quotation Procurement Method to invite suppliers to participate in this process.

River Gee County Administration wishes to state the following fact and reason for the use of Request for Quotation Procurement Method to conduct the procurement process for goods contained in the attached Procurement Plan for the running of the County Service Center:

STATEMENT OF FACTS

- 1. River Gee County Service Center currently lacks essential Stationery items required for effective administrative operation.
- 2. The County Service also requires 32.313 Gallons Fuel & Lubricants for its AG100 Yamaha Motorbike assigned for used by the Coordinator.
- 3. The Service Center intends to procure spare parts for its AG100 Yamaha Motorbike assigned to the County Service Center which has been almost permanently grounded and requires serious repair works. This motorbike has been one of the most important transport equipment used by all Line Ministries and Agencies assigned at the Service Center in facilitating their movement across the County.
- 4. The Service Center further intends to procure Cleaning Materials for the maintenance of all administrative offices and lavatories.
- 5. Additionally, the Service Center building requires renovation works to repair damaged parts of the building. We therefore intend to procure some building materials to carry out the repair work on the building.
