Subject: REQUEST FOR "NO OBJECTION" TO AWARD CONTRACTS TO ASIAN LIBERIA INVESTMENT LIMITED (LOT #1) AND QUALITY GROUP OF COMPANIES (LOT #2), FOR THE SUPPLY AND INSTALLATION OF SOLAR PANEL STREET LIGHTS WITHIN FIFTEEN (15) COUNTIES.

We present our compliments and wish to acknowledge receipt of your letter and accompanying documents, which sought the approval of the Commission for the Rural Renewable Energy Agency (RREA) to award Contracts to Asian Liberia Limited Investment (Lot#1), for the Supply and Installation of 4662 Poles of Solar Panel Street Light at the estimated cost of one million four hundred forty-nine thousand nine hundred ninety-eight United States Dollars and fifty cents (US\$1,499,998.50), and Quality Group of Companies (Lot#2), for the Supply and Installation of 5338 Poles Pieces of Solar Panel at the estimated cost of one million nine hundred ninety thousand eight hundred seventy-six United States Dollars and forty-nine cents (US\$1,990,876.49), respectively.

The Commission, upon review of your submissions, observes the following:

- That this activity is outlaid in the RREA's approved Special Project Procurement Plan;
- That the Rural Renewable Energy Agency submitted (Hard copies) including: <u>bid</u>
   <u>documents</u>, <u>bid evaluation report</u>, <u>procurement committee meeting minutes</u>, <u>bid opening</u>
   <u>minutes</u>, <u>draft contracts</u>, etc.;
- That RREA's BEP Report indicates that three (3) bidders participated in the bidding process (Asian Liberia Investment Limited, Quality Group of Companies and East International Group Inc.)
- That as per the RREA's BEP Report, only Asian Liberia Limited Investment and Quality Group of Companies were deemed responsive for the technical and financial evaluation.

The Commission, upon review of all submitted documentations and subsequent clarifications, states the below:

That a "No Objection" is rendered to the Rural Renewable Energy Agency for the award of contract<sup>6</sup> to:

- Asian Liberia Investment Limited (Lot#1) Supply and Installation of 4662 Poles of Solar Panel Street Light in the stipulated amount of U\$\$1,499,998.50, and
- Quality Group of Construction Companies (Lot#2) Supply and Installation of 5338 Poles Pieces of Solar Panel, in the amount of US\$1,990,876.49.

The RREA is advised to ensure <u>quality conformance</u> for this procurement, given the works under consideration.
