

Contract Agreement

This CONTRACT (hereinafter called the "**Supply of Two (2) Double-Cabin Pickups**") is made the **1st** day of the month of **April**, 2020 between, on the one hand, **The Sinoe Community College** (hereinafter called the "Purchaser") and, on the other hand, **GBK Motors** (hereinafter called the "Service Provider").

WHEREAS

- (a) the Purchaser has requested the Service Provider to provide certain Services as defined in the General Conditions of Contract attached to this Contract (hereinafter called the "Services");
- (b) the Service Provider, having represented to the Purchaser that they have the required professional skills, and personnel and technical resources, have agreed to provide the Services on the terms and conditions set forth in this Contract at a contract price of: **Sixty-seven Thousand Seven Hundred United States dollars (US\$67,700.00)**
- (c) The Purchaser hereby covenants to pay the Supplier in consideration of the provision of the Services and Related Goods and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.

NOW THEREFORE the parties hereto hereby agree as follows:


1. The following documents shall be deemed to form and be read and construed as part of this Agreement, and the priority of the documents shall be as follows:
 - (a) The Letter of Acceptance;
 - (b) The Service Provider's Bid
 - (c) The Special Conditions of Contract;
 - (d) The General Conditions of Contract;
 - (e) The Specifications;
 - (f) The Priced Activity Schedule;
2. The mutual rights and obligations of the Purchaser and the Service Provider shall be as set forth in the Contract, in particular:
 - (a) The Service Provider shall carry out the Services in accordance with the provisions of the Contract; and
 - (b) The Purchaser shall make payments to the Service Provider in accordance with the provisions of the Contract.



This Notification of Award will constitute the formation of Contract.


