Subject: "NO OBJECTION" TO USE FRAMEWORK CONTRACT AGREEMENT TO AWARD CONTRACT TO AMINATA AND SONS INC. FOR THE SUPPLY AND DELIVERY OF PETROLEUM PRODUCTS - FISCAL YEAR 2022

We present our compliments and wish to acknowledge receipt of your letter which sought the approval of the Commission for **The Liberian Senate** to award a framework contract to Aminata and Son. Inc. for the supply and delivery of petroleum products in the amount of one million six hundred forty-one thousand six hundred ninety-six United States Dollars and ninety-one cents **US\$1,641,696.91.**

The Commission, upon review of your submissions, highlights the following:

- That **The Liberian Senate** submitted (**Hard copies**) including: <u>bid documents</u>, <u>bid evaluation</u> report, procurement committee meeting minutes, bid opening minutes, etc.;
- That HOS' submissions indicates that six (6) companies received invitations to participate in a restricted bidding process and only two (2) submitted bids (Aminata & Sons, Inc., and Super Petroleum Corporation);
- That HOS' BEP Report shows that <u>Aminata and Sons, Inc.</u> emerged as the successful bidder.

The Commission, upon overall review of your submission renders "No Objection" for **The Liberian Senate** to award a framework contract to <u>Aminata and Sons, Inc.</u> for the supply of the goods as indicated above and in the stipulated monthly amount not to exceed one hundred thirty-six thousand eight hundred eight United States Dollars and seventy-five cents <u>US\$136,808.075</u>.

Kindly be reminded that all contracts which cumulative annual value exceeds the threshold of **US\$250,000.00** must be signed by the Minister responsible for Finance and attested to by the Minister responsible for Justice.

The Public Procurement and Concessions Commission admonishes and deems it a priority that you remain, **primarily**, in compliance with the PPCA, 2010, as we jointly aspire to achieve Transparency Accountability, Fairness, Equality and ultimately public confidence in our procurement and concessions processes.
