PUBLIC PROCUREMENT & CONCESSIONS COMMISSION Update on PPCC Activities January to August 8, 2006

The Public Procurement & Concessions Commission (PPCC) was established by the Public Procurement & Concessions Act (PPCA), which came into force with the inauguration of the Elected Government on January 16, 2006. Below is an update on PPCC activities:

Conclusion

The first round of our compliance monitoring exercises showed that procuring entities:

- 1. Are fully aware of the existence and provisions of the Public Procurement & Concessions Act.
- 2. Have to a large extent established the procurement committees and procurement units within their entities.

3. Have begun to allow broader participation of bidders through competition and ensure transparency by advertising procurement needs in the newspapers.

Short-comings

All of the procuring entities have demonstrated the urgent need for training in:

- 1. How and when to place a procurement advertisement in the newspapers or solicit direct quotations and the procurement methods to use.
- 2. How to prepare and what kinds of bidding documents to prepare for each kind of procurement.
- 3. How to prepare the procurement work plans, reports and maintain documents/records.

Next Steps

Three procurement specialists have been selected and are being recruited from the sub-region (Nigeria, Ghana & Liberia) for eighteen (18) months each to assist the capable staff of the PPCC in the preparation of all of the manuals, regulations, procedures, policies and training needed to ensure the successful implementation of this program.
