

Furthermore, WRTTI is advised to ensure that its IFB is published in at least two (2) widely read papers and on the Commission's website, as required by regulation 30(2) of the PPCA, to attain more competition.

The Public Procurement and Concessions Commission admonishes and deems it a priority that you remain primarily in compliance with the PPCA, 2010, as we jointly aspire to achieve transparency, accountability, fairness, equality and ultimately public confidence in our procurement and concessions processes.
